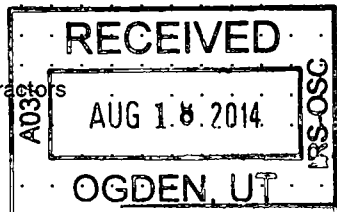

- Rescue, Rehab and Rehome using our network of nurturing foster homes,
- Sterilize all dogs brought into the rescue and educate the public on the importance of spay/neuter for both animal wellness and population control,
- Assist other animal rescues and shelters with GSD transport and placement,
- Adopt out rescued GSDs to qualified homes that have been properly screened and counseled by our adoption coordinators and foster parents,
- Educate the public on the benefits of adopting a dog as an alternative to purchasing one from a puppy mill or unqualified backyard breeder;
- Educate all dog owners about the importance of basic obedience training and proper care of their canine family member
